CLASSIFICATION TITLE: FLSA STATUS: SAFETY SENSITIVE: BUILDING INSPECTOR – non-certified NON-EXEMPT SUBJECT TO RANDOM DRUG AND BREATH ALCOHOL TESTING

PURPOSE OF CLASSIFICATION

The purpose of this job is to perform specialized work associated with ensuring that buildings, structures, premises, plumbing, electrical, and mechanical systems meet applicable building code standards for protection of life, safety, and welfare of the public, contractors and occupants. Duties and responsibilities include reviewing blueprints and construction plans, performing site inspections, enforcing applicable codes/regulations, maintaining records, and providing information and assistance. Report to Building Codes Director.

ESSENTIAL FUNCTIONS

The following duties are normal for this position. The omission of specific statements of the duties does not exclude them from the classification if the work is similar, related, or a logical assignment for this classification. Other duties may be required and assigned.

Administers and enforces the provisions of federal, state and local building codes and zoning ordinances.

Assists in performing site inspections of construction work, buildings, and related systems for compliance with approved plans and with applicable codes; in training to approve construction work during progressive stages of construction through site visits and inspections of footing, framing, gas systems, plumbing systems, mechanical systems, energy efficiency, insulation and final inspections.

Coordinate inspection activities with owners, contractors, other inspectors, or other individuals.

Assist in issuing permits as appropriate.

Prepares and/or generates routine correspondence, letters, memoranda, forms, logs, reports, and other documents via computer.

Receives various forms, reports, correspondence, permits, blueprints, construction plans, architectural drawings, manuals, reference materials, or other documentation; reviews, maintains, completes, processes, forwards or retains as appropriate.

Operates a computer to enter, retrieve, review or modify data; verifies accuracy of entered data and makes corrections; utilizes word processing, spreadsheet, database, or other software programs.

Maintains file system of departmental records.

Answers incoming telephone calls; provides information, guidance and assistance; records/relays messages or directs calls to appropriate personnel; returns calls as necessary; responds to requests for service or assistance.

Communicate with supervisor, employees, other departments, county officials, property owners, contractors, developers, inspectors, the public, and other individuals as needed to coordinate work activities, review status of work, exchange information, or resolve problems.

Issues violation notices and stop-work orders, confers with homeowners, contractors, sub-contractors, and authorities to explain regulations, evaluate and recommend recertification and solutions.

Uses measuring devices to measure dimensions, verify level alignment and elevation of structures, equipments and fixtures. Also uses test equipment, such as concrete strength measurers, to perform inspections and ensure compliance to building plans and codes.

Reviews and interprets construction plans, blueprints, site layouts, specifications and construction methods to ensure compliance to legal requirements and safety regulations.

Maintain daily logs and supplement inspection records with photographs, maintain file system of department records.

Perform on-site inspections periodically throughout the building process for local and State mandated Strom Water and Erosion Control compliance.

Must work hours as scheduled.

Completes work at assigned work station as determined by supervisor.

ADDITIONAL FUNCTIONS

Operates a motor vehicle to conduct inspections or other work activities; responsible for maintaining records and maintenance of vehicle.

Performs other related duties as required.

MINIMUM QUALIFICATIONS

High school diploma or GED; supplemented by one (1) year previous experience and/or training involving building inspection; or any equivalent combination of education, training, and experience which provides the requisite knowledge, skills, and abilities for this job. May possess the following certifications: Residential Building Inspector, Residential Plumbing Inspector and Residential Mechanical/Fuel Gas Inspector. Must possess and maintain a valid Tennessee driver's license.

PERFORMANCE APTITUDES

<u>Data Utilization</u>: Requires the ability to evaluate, audit, deduce, and/or assess data using established criteria. Includes exercising discretion in determining actual or probable consequences and in referencing such evaluation to identify and select alternatives.

<u>Human Interaction</u>: Requires the ability to provide guidance, assistance, and/or interpretation to others regarding the application of procedures and standards to specific situations.

Equipment, Machinery, Tools, and Materials Utilization: Requires the ability to operate, maneuver and/or control the actions of equipment, machinery, tools, and/or materials used in performing essential functions.

<u>Verbal Aptitude</u>: Requires the ability to utilize a wide variety of reference, descriptive, advisory and/or design data and information.

<u>Mathematical Aptitude</u>: Requires the ability to perform addition, subtraction, multiplication and division; ability to calculate decimals and percentages; may include ability to perform mathematical operations with fractions; may include ability to compute discount, interest, profit and loss, ratio and proportion, wind load, BTU, and energy efficiency; may include ability to calculate surface areas, volumes, weights, and measures.

Functional Reasoning: Requires the ability to apply principles of rational systems; to interpret instructions furnished in written, oral, diagrammatic, or schedule form; and to exercise independent judgment to adopt or modify methods and standards to meet variations in assigned objectives.

<u>Situational Reasoning</u>: Requires the ability to exercise judgment, decisiveness and creativity in situations involving evaluation of information against measurable or verifiable criteria.

ADA COMPLIANCE/PHYSICAL DEMANDS ANALYSIS

Physical Ability: Tasks require the ability to exert moderate, though not constant physical effort, typically involving some combination of climbing and balancing, stooping, kneeling, crouching, and crawling, and which may involve some lifting, carrying, pushing and/or pulling of objects and materials of moderate weight (12-20 pounds).

<u>Sensory Requirements</u>: Some tasks require the ability to perceive and discriminate colors or shades of colors, sounds, depth, texture, and visual cues or signals. Some tasks require the ability to communicate orally.

Environmental Factors: Performance of essential functions may require exposure to adverse environmental conditions, such as dirt, dust, pollen, wetness, humidity, rain, temperature extremes, electric currents, traffic hazards, or bright/dim light.
